This issue reflects our focus on continuing to foster strong, constructive relationships with our local communities.

In early April, we hosted a successful three day technical workshop in Yellowknife. Several people joined us in person and online for an in-depth review of the different aspects of the proposed Pine Point mine development project. We covered everything from health and safety, environmental aspects, proposed operational approach, to mine closure and reclamation. We did deep dives on water management, water quality, hydrology, hydrogeology, and aquatic risk assessments. We dug into soil, vegetation, and archeology, as well as wildlife habitats. And we examined Indigenous Knowledge, culture, and well-being, along with other social and cultural factors, among other things. It included detailed approaches presented over three days.

This generated invaluable feedback from regulators and Indigenous and local community leaders on our plans going forward. We know that community support is critical and look forward to incorporating feedback where possible into our plans as we move forward.

That's why we are pleased to launch some key updates to our website. You can now submit your comments and feedback to us in a variety of ways. If you have a grievance, you can fill out a form that gets submitted directly to our community relations team. If you want to share a story about Pine Point's history, we have a portal for that. # A successful technical workshop in Yellowknife

A big thank you to everyone who joined us for our first technical workshop. Held in Yellowknife in early April, representatives of regulatory bodies and local Indigenous communities joined us in person and online for four days to review and discuss key aspects of the Pine Point Mining Project.

Discipline leads from the Developer's Assessment Report (DAR) team—including air quality, health, environment, noise, reclamation, and water, among others—gave detailed presentations about their area of focus, including key assumptions, methodologies, and preliminary results

Key goals were not just to give a technical update, but to gather feedback on our assumptions and methods, so that feedback can be incorporated where possible.

We appreciate each and every comment. These contributions are essential to the ongoing development of a robust and transparent environmental assessment process. Thank you for your contributions, we could not do it without you.

## WHAT'S UP AT SITE





As we wrote about in our last Pine Pointer, while we closed the exploration camp December, we are still working hard on moving the project forward. In that issue, we reported on how we were focused on preparing the feasibility study, a critical step in determining the technical and economic viability of a mining project.

This comprehensive analysis and rigorous evaluation of all the project's aspects will provide crucial insights into the project's potential, guiding future development decisions. We are on track for completing this as soon as possible this year.

Another report that we are working on is the Developer's Assessment Report (DAR). A DAR evaluates the potential environmental, social, and economic impacts of a proposed mining project, outlining how to mitigate negative impacts and how to maximize potential benefits.

It's partly why we have been focused on connecting with our local communities to host townhalls and foster constructive relationships that will provide a strong foundation for the DAR.

We hope to submit the DAR within the next year. It will also mark the formal start of the Environmental Assessment process. Our ultimate objective is to receive all our relevant operating permits by 2028.
